7. LICENSE REQUESTS CONSIDERED INDIVIDUALLY

Personal appearance will be required for the following application due to a revocation of registration of record: Electrical Registration

The Way Electrical Solutions LLC - David George (Examinee Changes Company Subject to an Administrative Lock until all 'A' Status Permits and Administrative Fines, if any, are Resolved)

Virjinia Koultchitzka provided a summary for the Committee regarding the reason why David George was asked to attend today's Licensing Committee meeting in person. The summary included the meeting minutes from the June 13, 2024 Licensing Committee meeting. On June 13, 2024, the Licensing Committee unanimously voted to revoke the electrical registration of David George and Radiant Electric LLC.

Ms. Koultchitzka also confirmed that the applicant is requesting reinstatement of the electrical registration, however, for a different company, The Way Electrical Solutions, LLC.

David George appeared in person and explained his situation, which he said was a reason, but not an excuse. Several years ago, he started to have mental health issues which became worse over the years and about nine months ago he was placed on a suicide hold. This was the reason he did not appear at the June 13, 2024 Licensing Committee meeting. He continues to attend recovery and ministry counseling and classes.

Mr. George stated that the reason for the business name change is so that someone else will own the company, and he can work with others and have accountability. He has attempted to return to all his previous projects that have outstanding permits and work with the property owners. He wants to have the opportunity to finish all seven permits, which are outstanding, and get back to work. At first, he had planned on being the owner of The Way Electrical Solutions, LLC, however, it will be owned by someone else; Mr. George will be the master electrician for the new company. He is closing the Radiant Electric, LLC company.

Luke Sanderson provided a summary and status of the seven outstanding permits obtained through Radiant Electric, LLC, which are all administratively dissolved.

Toby Conquest commended Mr. George for showing up at the Licensing Committee meeting on this date and thanked him for being transparent with his personal situation. He asked the applicant about the "unresolved permits" which are part of his registration application and what his plans were to handle this part. Mr. George stated that most of the permits are ready for final inspections, but since he was advised by the Department that he could not work as an electrician until he was registered again, he was waiting until today's meeting to find out what he can do to finish up everything, again stating he would appreciate the opportunity to return to work. Mr. Sanderson advised that it is the Department's standard process when someone changes a company which has unresolved permits, the permits are transferred to the new company to follow the registrant. Once the applicant pays any and all administrative fines and other outstanding fees, he will then be able to work on completing the pending A-status permits. While the permits are being finalized, Mr. George's registration would be in a locked status.

A motion was made by Toby Conquest to recommend to the Board of Review APPROVAL of the registration renewal and transfer of David George's registration to The Way Electrical Solutions, LLC, under the condition that any and all administrative fines and fees are paid in full and all pending permits are finalized; seconded by Trevit Smith; the motion carried unanimously.
